## The Valor Program at Embrave:

## Supporting individuals in the competency continuum and rebuilding lives across Colorado

The Valor Program at Embrave is in Colorado Springs, near Garden of the Gods State Park. Valor accepts individuals who are currently in the competency continuum or who have a history of being involved with the competency system. This includes individuals found incompetent to proceed in their legal process, who are awaiting competency restoration education, have been restored to competency and needing step down supports until their court proceedings are completed, and those who are at risk of returning to the competency system.

Valor provides 24/7 staff support at a staff secured facility with monitored entry. Services provided include medication monitoring, in-house daily meals, and personalized programming in an integrated-person-centered therapeutic community. When needed, Valor is also an Outpatient Restoration provider. Transportation is provided to Valor, court appearances (when virtual is not available), and justice appointments. Additionally, community transportation is provided to assist individuals with meeting their basic needs and to encourage prosocial activity. Valor can accommodate individuals who need electronic monitoring.

If an individual is adamant about leaving the community-based program, Valor will not restrain or confine the individual. If an individual decides to abscond from the facility, notifications will be made to the referring entity.
